New Zealand China Council 2013/14 Chairman's Report

I am pleased to present the New Zealand China Council Chairman's Report for the 2013/14 financial year and to update the Council on recent developments.

The New Zealand China Relationship

The past 12 months have again seen significant developments in the relationship between New Zealand and China so it's worth highlighting some of the events and issues in the last year:

- China has become New Zealand's largest merchandise trading partner.
 This achievement also meant that we reached the New Zealand and China leaders' goal of NZ\$20 billion in bilateral merchandise trade a year early.
 In addition, New Zealand is now trading with a healthy balance of payments surplus.
- This was achieved despite China being an increasingly complex and challenging operating environment; in the World Bank Report, China ranked 91st in the Ease of Doing Business Survey and is set to fall to number 96.
- China is New Zealand's second largest source of inbound tourism, with numbers growing at 8% from the previous year and China remains the largest source of overseas students, with inbound student visa applications growing to record levels.
- The New Zealand government increased its commitment to resourcing in China considerably, including the progression of the new Embassy in Beijing, additional New Zealand staff now based in Beijing and Shanghai and the confirmation of a Consulate General in Chengdu, Western China.
- The year included considerable challenges with food safety and trade access issues, and while these issues did not in themselves result in a downturn in exports, they drew down on our positive working relationship and complicated access for New Zealand companies.
- Overall, the relationship remained strong with another well-received visit to China in February 2014 by the Prime Minister with a diary/food delegation.

New Zealand China Council

The New Zealand China Council has largely completed the establishment of its operating structure, including setting up a permanent office in October 2013 with NZCTA and Stephen Jacobi Consulting, completing the branding project and working through the registration process, tendering and appointing Sputnik PR as Mar/Coms partner and launching the NZ China Council website. In addition, an Executive Administrator was appointed in late January 2014. The Council was fully operational by the start of 2014.

Three Pillars

Early in the year, the Council committed to focusing on 'three pillars'; Language and Culture, Value from Investment and Dissemination of

Information. These became the key themes guiding Council activity throughout the 2013/14 year, which included:

- Presentations at more than 25 conferences and seminars throughout New Zealand and one in Australia
- A follow up visit to China in November 2013 with the Chairman and Cathy Quinn meeting with Chinese leaders, corporates and the New Zealand community
- Running the major event of the year, the China Business Forum in February 2014, in conjunction with ABAC, Business New Zealand and the APEC Chinese Business Council
- Running and hosting other events including the China Council Prime Ministerial breakfast, a post-Board networking event in Wellington and the China Heads of Mission Breakfast Briefing in Auckland.
- Sponsoring and participating in a range of other China events in New Zealand: The China Summit, ABAC/ACBC visit, China Symposium and Diverse Bananas
- Sponsoring the prize for the New Zealand Chinese Speaking Competition: China Bridge
- Hosting senior Chinese officials, including the Assistant Minister for Foreign Affairs, former Minister for Foreign Affairs and the Deputy Governor of the Bank of China
- Generating more than 20 editorial articles, OpEds and interviews through the partnership with Sputnik, in the main centers and also out into the regions.
- Following the launch of the website, gathering over 1,500 viewers, with more than 50 additional events, articles and announcements since the launch.
- In addition, the Council has continued to update the stats series, making this available widely to interested parties, especially media.
- The Council also worked in partnership with a wide range of organizations and agencies, well beyond those directly involved in the Council, so is now well integrated with "NZ Inc".

Membership

Membership of the Council now stands at 18 on the Executive Board, plus 3 non-sitting and 16 on the Advisory Board, plus the Executive Director. Changes to the Council include:

- From the Executive, the departure of Michael Stedman and the addition of Peter McBride, Chairman Zespri New Zealand and the involvement of the non-sitting IBF members of the Council, Graham Stuart, CEO Sealord, James Parsons, Chair Beef and Lamb New Zealand and Phil O'Rielly CEO Business New Zealand.
- On the Advisory, Daniel Harrison from Asia New Zealand Foundation and Mike Houlihan from Te Papa moved on and we were joined by Brent Robinson of Rakon, Sir Mark Solomon of Ngaitahu, Sir Stephen Tindal of Warehouse and Jordan Lee NZCTA Young Leaders.

Thanks also to John Allen from the Ministry for Foreign Affairs and Trade for their on going funding commitment to the Council and in conjunction with Peter Chrisp from New Zealand Trade and Enterprise for providing additional funding for our Executive Administrator.

While still a relatively new organization, the NZ China Council is playing an increasingly valuable and proactive role, and making important contributions to the New Zealand China relationship. This would not have been possible without your financial support, but also your participation and commitment to the activities of the NZ China Council. Once again, thank you for your support and involvement.
